First Nations leaders, advocates and communities are working together to ensure that all Australians understand the significance of this vote.

In coming together to support the campaign for a Yes vote, we have a rare chance to build on this work and make a major positive impact now and for future generations, enabling Indigenous communities to have a say on matters that impact them rather than have decisions made on their behalf.

# **Educating community on Voice, Treaty, Truth**

The Uluru Statement from the Heart, born from generations of advocacy, put forth an invitation to the Australian people to create a better future through a series of reforms.

The Uluru Dialogue, based at the Indigenous Law Centre UNSW, continues to carry the cultural authority and the mandate of the Uluru Statement through the four pillars of its referendum campaigning:

- Maintaining and growing First Nations
   Peoples consensus through facilitated dialogues, workshops and community events, and elevating First Nations voices;
- Providing leadership to influence political, media and community decisions and discourse through a comprehensive proactive earned and social media strategy, partnerships, events, speaking engagements and political engagement;

- Providing legal and technical expertise, including playing a key role in the three formal government referendum working groups, leading legal and policy work with the Indigenous Law Centre, and advising on the drafting of the Constitutional amendment and referendum ballot question; and
- Educating the Australian community with a research-informed and targeted influencer, advertising and digital strategy.

#### \$50,000 RAISED | \$250,000 TARGET

Passing the Message Stick is a multi-year research project shifting public narrative in support of First Nations justice and self-determination. The foundational research has already been widely adopted by First Nations organisations, advocates, journalists and allies.

As we approach the Referendum, Passing the Message Stick is prioritising research on two issues where there is momentum and opportunity for substantive change: transformative policy change, and law reform and justice.

The project will see an extensive national rollout to share the research far and wide, equipping communities with the tools and skills to apply effective messages to their campaigns. Project activities include:

- Conduct and share research with First Nations advocates and organisations
- Train 50-100 First Nations media spokespeople
- Develop a train-the-trainer model for five First Nations Messaging Fellows
- Share the research more widely with a further 5,000+ advocates and journalists
- Build on existing website and resources.

# Coordinating a national campaign for Yes

#### \$50,000 RAISED | \$250,000 TARGET

Australians for Indigenous Constitutional Recognition (AICR) is the key fundraising and organising vehicle in the campaign for Constitutional Recognition through a Voice to Parliament.

In the lead-up to the Referendum, AICR is enabling all Australians to be a part of this historic opportunity through a national campaign: Yes 23.

AICR's work this year includes the development of a strategic communications plan (encompassing creative and mass communications, narrative and messaging, earned and paid media), government relations, and on-the-ground conversations, all underpinned and informed by detailed research and insights.

To support the campaign, AICR is convening the Yes Alliance – a growing network of organisations and supporters. The Alliance encompasses many committed First Nations-led organisations and community groups, and allies.

A defining feature of AICR's work is a Capacity Fund, managed by AICR and administered by Australian Communities Foundation, to provide funding for Yes Alliance partners to build their capacity and undertake aligned campaign activities on the ground in their own communities.

# **ACF Rapid Response Referendum Grants Pool**

#### \$50,000 RAISED | \$250,000 TARGET

Australian Communities Foundation is launching the Rapid Response Referendum Grants Pool to support community groups and organisations all over the country mobilising around different aspects of the campaign.

Recognising the unique role we can play with our capacity for quick and effective grantmaking, we are launching the Grants Pool to complement the Capacity Fund led by Australians for Indigenous Constitutional Recognition.

Our established infrastructure and processes will enable us to get resources out quickly in response to immediate need and fill gaps as they arise throughout the campaign.

Small grants (\$5,000 – \$10,000) will be provided to support local efforts that elevate First Nations voices and enable accessibility of information and resources about Voice, Treaty, Truth and the Referendum for all communities.

Our First Nations Advisory Group will develop a simple and culturally appropriate application process, including clear guidelines and a transparent decision-making framework.
